1) Sensorial Examination (DIN 10955:2024):

Food simulant: Water • Test condition: 100°C for 2 hours.

Result: No discernible deviation in smell or taste (score 0/0; limit for failure = 3).

2) Specific Release of Metals (ICP-MS):

Methodology with reference to the Technical Guide on Metals and Alloys used in Food Contact Materials; migration behaviour per Commission Regulation (EU) 10/2011, Chapter V, Article 18 (as referenced).

Food simulant: Artificial tap water • Condition: 100°C for 2 hours • V/S ratio: 118 mL/dm².

Key finding: All measured elements were below the specified limits. For Aluminium (Al), the 3rd test result was 4.4 mg/kg (limit 5 mg/kg); sums of 1st+2nd test for all metals were within the sevenfold limits.
