

The materials and raw materials used comply with the German Commodity Ordinance (or the respective stipulations laid down in the European Regulation (EC) No1935/2004 and the Regulation (EU) No 10/2011, respectively according to the latest version.



Specification on the intended purpose of use or limitations:

Type/types of food intended to come into contact with the material:

• Food, drinkable liquids, hot or cold

Type/types of food which should NOT come into contact with insulated containers:

• Milk products, cooking oils or fats unless the product is explicitly designed for this purpose.

Since a functional barrier of plastic is used in a number of products, we confirm that the special provisions of the Foodstuffs and Consumer Goods Law (equivalent to Regulation (EU) No 10/2011) are complied with.

This declaration of conformity is applicable to the product supplied by us as described. Directives 82/711/EEC and 85/572/EEC provide guidelines as to the selection of test conditions to be applied for different types of food. Accordingly, the product meets the provisions of these directives in terms of containing food and beverages according to the specifications. It is in the responsibility of users to assure themselves with regard to any product suitability for fillings not covered by the directive provisions.
