Compliance with National Regulations in the EU:

The coating, complies with BfR Recommendation: LI. Temperature Resistant Polymer Coating Systems for Frying, Cooking and Baking Utensils, and with the Council of Europe Policy Statement concerning Coatings intended to come into Contact with Foodstuffs, Version 2, 29.01.2008.

The articles comply with French and Italian regulations regarding composition of metallic food contact materials.

We declare that the migration of metals from the articles comply with the worst case requirements in EU-national regulations on metallic food contact materials.

US-FDA Compliance:

The coating complies with US-FDA CFR 21 § 175.210 - 390, Substances for use as components of coatings, and § 177.1380, Fluorocarbon resins.

The metal part of the articles comply with US requirements regarding metallic food contact materials and articles, specifically the FOOD CODE 2009 and NSF/ANSI 51 – 2012 on Food Equipment Materials

MERCOSUR/MERCOSUL Compliance:

The articles comply with Código Alimentario Argentino, MERCOSUR/GMC/RES N° 03/92, relevant sections of MERCOSUR/GMC/RES. N° 02/12 (plastics), and MERCOSUR/GMC/RES. N° 46/06 (metallic food contact materials).

Coated articles are only intended for use with an intact coating, and this Declaration of Compliance only covers migration from articles with intact coatings.

The articles are intended for preparation and serving of food at temperatures up to 260 °C

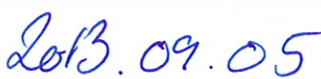

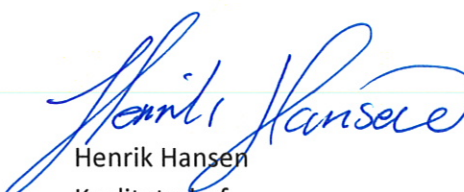
