Reels, bundles, shirred strands, tied or cut pieces

Printing

Print with up to 8 colours, both sides and on its entire surface.

Storage time

Always store NaloBar in a cool (< 25 °C) and dry place using the original packaging. Protect from frost. By observing these recommendations a storage time of 36 months can be achieved. With pre-moistened casings, the storage time is 6 months.
