1) We hereby declare that the material or the item:

The materials contains substances subjected to restrictions in accordance with the laws above mentioned; it respects the limits of overall migration and the specific restrictions in the proof terms as follows:

The overall migration limit and all the other specific restrictions, whose the monomers or/and the additives are subjected to, are respected in accordance with the usage conditions above mentioned. The assertion is supported by analytical proves, carried out in accordance with the Directives 82/711/EEC and 85/572/EEC and with the DM 21/03/73 or on the basis of calculations carried out considering the content of the substances subjected to migration limits. The computations have been arranged assuming that 1 kg of food comes in contact with 6 dm² of packaging material.

The material **can** contain substances regulated by the directives 89/107/EC and 88/388/EC, by the DM 27/02/1996, No 20, by DL 25/01/1992, No 107, by the DL 27/01/1992 No 109 and by the decision 1999/21/EEC. According to experimental or theoretical data, these substances comply with what disposed by the art. 5 bis of the Directive 2002/72/EC and art. 9 subsection 2, letter C and by the DM 21/3/73. It is the responsibility of the user of the material intended to come in contact with foodstuff, to communicate to our company possible restrictions regarding the components (presence of additive and aromas) of the food that must be packed.

This declaration in valid for 24 months after the below date, and it will be previously replaced in case of changes in the production/formulation of the material, or if the law references in point 1 will be revised and updated so that a new compliance checking is required.
